



Overview of the BYO iPad 1:1 Program

The BYO (Bring Your Own) iPad Program refers to each student in the classroom having their own personal device that they use at school and home. Having a 1:1 ratio allows every student to seamlessly transition between activities involving technology and traditional learning throughout the school day. Utilising technology in the classroom provides students with limitless possibilities to participate with content and demonstrate their knowledge in engaging and interactive ways.

Our reason for integrating a BYO iPad 1:1 Program in Years 3-6 is to effectively implement the requirements of the <u>WA ICT General Capabilities</u> and <u>WA Digital Technology Curriculum</u>, and to prepare students with the skills they require for high school and the modern day workforce.

Students in Years 3-6 are required to bring an **Apple iPad** to use as a tool to enhance and assist their learning.

Why Apple iPads?

Aspiri Primary School has engaged in a significant amount of research and explored a number of possibilities when deciding upon the most appropriate technology to support students to meet the curriculum requirements. Apple iPads have been selected due to the following benefits:





- Cost efficient
- Lightweight and portable (small in size)
- Versatile range of learning applications
- Reliable and stable
- User friendly and age adaptable
- Accessibility features and enhanced security
- Provides opportunities for creativity and collaboration



Considerations:

- The newer the iPad, the longer it will be able to accommodate future software and app purchases
- Airplay and Airdrop functions are supported with the latest model iPads
- Available technology on new versions of the iPad are of greater capacity and quality than previous devices. An iPad compatible with the latest operating system (iOS) enables access to features such as Files, including the ability to save to file servers or external drives, easier text editing, slide over and split views for easier multitasking between applications
- Styluses such as Apple pencils and Logitech crayons are compatible with Apple iPads

Hardware

In order to work efficiently and ensure compatibility with the school system and classroom needs, devices <u>must</u> have the following features:

- be an Apple iPad (9th generation onwards)
- have iOS18.0 installed
- data storage of at least 64gb

Please note: alternative devices, including Android tablets, iPad minis, iPad Pros and iPads with a sim card (which use mobile cellular 3G/4G/5G data) will not be permitted.

Software / Application Lists


Prior to bringing their iPad to school for the start of the year, it is important for students to have all applications (as specified on the <u>school app list</u>) installed on their device. This will enable your child to use their iPad effectively for learning at school.

All applications required are tried and tested and have been kept to a minimum number to ensure the focus is on students developing skills in using ICT with an educational purpose and to enhance creativity.

Some applications come preinstalled on the iPad, others are free to download and some are paid applications. If your child is part of the management system new to Aspiri in 2025, the applications will be installed onto the student device. If your child is part of the unmanaged system, parents/carers will be required to download the applications onto the student iPad. Although the applications stated on our core applications list are for 2025, additional applications may be added throughout the year.









Purchasing Options

Aspiri Primary School has partnered with JB HiFi to provide iPads at a discounted price to the parent community with the following benefits:

- discounted education pricing on all requirements (i.e. iPad, keyboard, cover etc)
- · optional two years of insurance
- collection available from nearest JB HiFi store

Some parents may wish to purchase devices as a Christmas present for their child before their child transitions to the new year level in 2025. Families wishing to take up this option may place an order online with JB HiFi:

Parents may opt to purchase an iPad elsewhere, however in doing so, we recommend careful consideration is given to the requirements, warranties and insurances when buying from other stores. Privately purchased devices will not necessarily have the same technical support provided to students whose device has been procured through the school's partnered provider.

AppleCare+

All Apple hardware comes with a one-year limited warranty and up to 90 days of complimentary telephone technical support. You can extend your coverage through AppleCare+ with a small additional cost, which provides a two year warranty extension. Insurance

Insurance is an important consideration as the iPad your child brings to school is not covered by the Aspiri Primary School or the Department of Education's insurance. It is the responsibility of parents to insure their child's device.





Device setup and Responsibilities

Device Setup- Unmanaged

Setting up a child's Apple ID account under <u>Family Sharing</u> allows parents to implement safety measures such as <u>Parental Controls</u> and <u>Screen Time</u> to block notifications and home applications from being accessed and used during school time. They may have personal apps installed on their devices, but these are **not to be used at school/during school hours**. This includes sending and responding to messages. Apple Classroom has been set up in all classrooms to assist staff in monitoring this.

Device Setup- Managed

Whilst at school, the use of student iPads will fall under the school management system JAMF. At the beginning of the school year, new devices to the program will be collected by the school and the Jamf supervision profile will be added to the device. This allows school-based applications to be installed automatically. As part of this process, devices are restored to factory settings, therefore we strongly recommend that any important data is backed up. Please note, you cannot restore a backup after JAMF has been added.

If you are bringing an existing household device to school, it will need to be restored to factory settings before the start of Term 1, 2025.

Battery (Charging)

The student is responsible for ensuring they charge their iPad battery each night as they will not be able to charge devices at school. Students need to have at least 80% charge before arriving each morning.

Student Responsibilities

- iPads are to be in their case when they are being carried around the school grounds.
- On arrival or leaving school grounds, iPads are to be kept in the student's bag.
- iPads will be used by students for learning and teaching outcomes only.
- Parents are not to be contacted through their device e.g emails or messaging.
- Students will not share or lend their iPad with other learners.

School Responsibilities

- Ensure all staff are trained in using common applications and platforms.
- Provide Cyber Safety resources for parents and students.
- Integrate ICT into the curriculum to maximise learning opportunities for students.
- Deliver the Digital Technologies curriculum to all students.
- A secure place will be provided for the storage of iPads when not in use.




Technologies Usage Agreements

Parents and students must agree to the terms of the Internet Usage Agreement: Online Services before online student accounts are accessed.

As per Department of Education policy, students will not be allowed to use personal or school iPads until consent forms for <u>Third Party Service Providers</u> are returned to the school.

Once these forms are completed, we strongly encourage you to sit down with your child and go through the BYO iPad 1:1 Program Years 3-6 Student Agreement so they understand the expectations of using technology and devices appropriately, as well as the consequences for misuse. This form must be read and signed by both parties (parent and student) and returned to school before students can bring and/or use a personal or school device in class.

The Apple iPad must not be used for any activity that is not directly and explicitly endorsed by the school and its staff.

Storage and Backup

It is important to organise the iPad regularly to allow for updates and new work. In order to free up space, any photos or documents that are unused and no longer needed, should be cleared or backed up. For those who wish to keep certain photos, videos, documents etc, here are a few options:

 Backing up to iCloud on the iPad https://support.apple.com/en-au/HT203977

Limit for free storage is 5gb. The iPad will not function well if the storage space on the hard disk or cloud becomes full.

 Student cloud storage using OneDrive (up to 1TB). This can be through the Microsoft app or online https://www.microsoft.com/en-au/microsoft-365/onedrive/online-cloud-storage

Students will need to log in using their Education Department log in credentials.

3. Using a Home PC/Desktop or external hard drive to back up data.

Promoting a Safe Learning Environment

As per the WA Department of Education guidelines, Internet and Online Services provided to students will primarily be used for learning related activities and require informed parental consent, user agreements and appropriate management. Online services are provided to students in public schools for learning related activities and the Department strives to protect students from exposure to inappropriate online material and activities.

Students engage in learning about ethical and safe use through online platforms. Lessons are consciously planned and implemented to enhance development of ICT skills and Digital Technologies understanding, in order to prepare them for an ever changing social, higher-education ever changing social, higher-education environment and future workforce.

We encourage students and teachers to safely and ethically access the internet and email, use organisational tools and engage with resources to innovate and transform their teaching and learning.

Our staff work hard to ensure that your child/ren are safe and that the environment that they work in is also safe. This also applies to use of iPads.

We take the following steps to ensure your student and their property is safe:

- Each student must read and sign the BYO iPad 1:1 Agreement and understand the Acceptable Internet Usage policies
- iPads are kept inside the classroom (not in bags)
- Students are not to use iPads before or after school in school grounds
- Classrooms are locked when the class is outside
- iPads are not to be used outside of the classroom without explicit teacher permission
- The school internet connection is provided by the Department of Education and passes through all of the filters for Public Schools
- Teachers address Cyber Safety through the Digital Technologies and Health curriculum- discussing issues on sharing personal information online, other online dangers, cyber bullying and the students' digital footprints





Privacy

Staff, parents/carers and the community need to encourage students to be aware of the risks associated with some online activities and how to adopt protective online behaviours to protect them from exposure to inappropriate online material or activities. Some suggestions are:

- Keep personal details private by using a nickname instead of a real name and always ask parents before giving out private information online (such as name, address or phone number)
- Keep usernames and passwords private
- When responding to others online, posts should be positive and constructive. Once posted, a message can be difficult to remove
- Always ask for permission/consent before taking and posting photos of others online
- Respect others' rights when consent is not given



Online Safety

Cyber Safety

Cyber safe practices are a high priority at Aspiri Primary School and appropriate duty of care is extended to all our digital environments. Students and parents also have a responsibility in this area to minimise risk or exposure to unsuitable material.

Students are prohibited from accessing or storing offensive images, video or audio on any ICT device used at school. This includes content that is offensive to other cultures, religions and learning abilities.

Any misuse of digital technology or online tools will result in students being subject to consequences as listed in the school's ICT Use policy and Behaviour Management policy.





Social Media

Most social media sites will only let users open an account under the prerequisite age requirement of 13 years and older. This is primarily for safety reasons, as young children do not understand the dangers of cyber predators, and because younger children have not yet developed the good judgement to know what is okay to post and what is not. They are also exposed to adult content via social networks and applications which can be suggestive or inappropriate. Cyberbullying is emerging as a pretty devastating and destructive outcome for young children as well.

With all of the above in mind, we have made a decision to ban all social network/social media/chat room-type applications from devices, with the implementation of Jamf management and Apple Classroom in 2025. We understand that some parents have used their parental discretion to allow their child to participate in social media at home, however at APS this will not be permitted.

Please understand that these measures are in place to protect the students at Aspiri PS. If your child is in the Years 3-6 Bring Your Own iPad Program, please ensure that these applications are deleted from your child's device that they bring to school.

If found on devices at school, we will exercise our right and obligation to report prohibited accounts.

Family Sharing & Child Apple ID

We request parents set up and manage their child's Apple ID account so they are can monitor student use of technology. One parent/carer can be nominated as the 'Family Organiser' to set up a Child's Apple ID for students under the age of 13.

Conditions: The Family Organiser must have an Apple device. Through Family Sharing, an additional 5 family members can be linked.

- Family members can use the applications without having to purchase new licences
- Family Organiser can retrieve forgotten passwords
- Before purchasing applications, children have to ask for permission (part of the 'Ask to Buy' function) from the Family Organiser
- The same music, movies, TV shows, books and applications can be accessed through File Sharing
- Family Organisers have the ability to limit their child's access on their device using Screen Time

Parental Controls



Screen Time

Content and Privacy restrictions offered through Screen Time can act to block out or limit specific apps and features on your child's device. You can:

- Set a Parent Passcode and Screen Time password to prevent other family members from changing settings
 - * Ensure the parent access passcode is different to the one used to unlock the device*
- iTunes and App Store purchases can be prevented
- Built in apps and features can be turned off
- Explicit content can be blocked from playing in music, films, TV shows with specific ratings, apps (ie. FaceTime) and web content, Siri searches and Game Centre functions.

Screen Time allows you to see how much time you and your children spend on apps, websites and more. In turn, this can help you to:

- Make informed choices about how you use your devices
- Set a Screen Time Passcode (different to passcode used to unlock device) to change Screen Time settings or provide additional time when application limits expire
- Get a detailed report about how the device is used, including applications which have been opened and websites visited
- Set Downtime or a set length of time to turn off specific applications (ie before bed)
- Set Application limits for categories of apps, including time limits and days of the week when these apply
- Set limits for communicating via Phone, Facetime and Messages



Device Use at Home

Aspiri Primary School strongly encourages active supervision of your child's use of technology at home. The internet is an excellent learning tool and enables access to information that supports all areas of our curriculum.

We suggest the following guidelines be followed when your child is using their iPad at home:

- Supervise your child in a public room like the family room
- Avoid your child accessing ICT in bedrooms or rooms that can be closed off to other members of the family
- Ensure that you establish some expectations regarding internet use at home and that you have the right to your child's passwords for any apps or websites that they may be using
- Check Internet browser's "History" menu to allow you to see the sites your child has visited recently

- Ensure your child never provides personal information on a global system or identifies friends or themselves in photos available to the public
- Educate yourself and your children about potential dangers online and how to make the right choices about online behaviour. Use readily available websites like www.cybersmart.gov.au to assist you
- Regularly monitor children's use of social media and their legal requirements - for example: children must be over the age of 13 to be eligible for Facebook and Instagram accounts

Please note that students will be using the device for approximately 2 -3 hours whilst at school.

This needs to be kept in mind when parents are determining how much time to allow the students to use the device at home.





BYO iPad 1:1 Program Years 3-6 Student Agreement 2025

This User Agreement is to ensure students using iPads enhance their learning in a safe, secure environment. It is also to help keep each device secure, working properly and used in a productive and appropriate manner. As the minimum age for opening most social media accounts is 13+, social networking websites and apps are not permitted on devices used in the BYO iPad 1:1 Program at Aspiri Primary School. If your child is found to have a social media account or app, we must exercise duty of care and have legal obligation to report prohibited accounts. Therefore, we ask that you ensure such applications are deleted from your child's device.

These are only available in extenuating circumstances (such as being new to the school or for students with a personal device in for repair) and <u>will not</u> be provided for students simply because they forgot to charge their iPad or left it at home.
